1.1

Presentation and guidelines

The Centre for Research and Studies in Sociology / Centro de Investigação e Estudos de Sociologia (CIES-IUL) of the University Institute of Lisbon / Instituto Universitário de Lisboa (ISCTE-IUL) is a R&D unit, recognised and evaluated by the FCT (Foundation for Science and Technology), in the area of social sciences dedicated to studying contemporary social problems from a multidisciplinary perspective. Constituted in 1985, it is an organic unit of ISCTE-IUL and is part of its School of Sociology and Public Policy.

CIES-IUL's main scientific domain is sociology, developing relevant activity in the fields of public policy, political science, communication, education, modern and contemporary history and social work.

CIES-IUL's activity is characterised by a demanding articulation between basic research, applied research mainly directed at the design, monitoring and evaluation of public policies in various sectors and areas of intervention and advanced training.

The Centre's research and scientific production, fosters diversity and the crossing of intensive and extensive approaches, aimed at deepening the analytical relationship between the study of social, political and historic macro-processes and the social, cultural and spatial micro-dynamics. Currently the research team is composed of 121 integrated PhD researchers, including a significant number of foreign researchers from 22 different nationalities (18% of integrated PhD full-time researchers). The Centre also hosts a growing number of visiting researchers.

CIES-IUL's integrated PhD researchers are mostly professors at ISCTE-IUL or full-time researchers at the Centre. Another part of the integrated PhD researchers belongs to other national university and polytechnic higher education institutions, among which the Beira Interior University - UBI, where the CIES-UBI Pole is located.

The scientific structure of CIES-IUL is based on 6 Research Groups:

- Inequalities, Migrations and Territories
- Knowledge Society, Competences and Communication
- Family, Generations and Health
- Politics and Citizenship
- Work, Innovation and Social Structures of the Economy
- Modern and Contemporary History.

The development of the CIES-IUL strategic programme is also anchored in a set of permanent research structures that are linked to the research groups and are one of the Centre's distinctive features. The Inequality Observatory and the Emigration Observatory illustrate this dynamic.

Advanced training is another fundamental pillar of CIES-IUL, closely combined with research activities. The centre is responsible for the scientific and ad-

ministrative coordination of 4 PhD programmes - <u>Sociology, Public Policy, Communication Sciences and Social Work</u> – and is associated with 6 others.

CIES-IUL regularly organizes national and international conferences in order to promote a dynamic environment of up-to-date scientific debate. Since its foundation, the Centre has also been continuously developing activities to promote scientific culture, in close connection with a large number of partners.

In the editorial field CIES-IUL publishes since 1986 the scientific journal <u>Sociologia</u>, <u>Problemas e Práticas</u> [Sociology, Problems and Practices]. The journal is indexed by several international databases such as SCOPUS and Thomson Reuters SciELO Citation Index. The Centre also publishes the <u>CIES e-Working Papers</u> and supports the indexed journals <u>Portuguese Journal of Social Science</u> and <u>Observatory (OBS*)</u>. Since 2010 CIES-IUL has its own publisher, <u>Mundos Sociais</u>, that publishes the journal and refereed social sciences' academic books.

Support services

The increasing complexity, globalization and competitiveness of scientific systems require professional management, which assures the use of the multiplicity of existing financing opportunities and the efficient use of resources, maximizing the scientific and social impact of the activities.

CIES-IUL has a set of support services to respond to this challenge, which include the Communication and Planning Office, the Financial and Administrative Services, the PhD Programmes Management and the services of the *Mundos Sociais* publisher and the journal *Sociology, Problemas e Práticas*.

In 2018, a total of nine full-time staff members were assigned to these services, supporting the research team and the Centre's governing bodies.

The functions performed by the Communication and Planning Office are twofold: to search for opportunities and to support the submission of applications for projects and other research activities and to monitor and manage the scientific activities in progress; and the organization of scientific events and other forms of dissemination of the activities and scientific results of the Centre, including activities that promote scientific culture.

The Financial and Administrative Services ensure the preparation and justification of budgets for applications and the financial management of ongoing research projects and activities, ensuring compliance with the procedures of the host institution and the requirements of the various funding institutions. These services also ensure the execution of the funds and financial prizes granted to members of the research team provided by ISCTE-IUL and other sources.

The PhD Management service accompanies the students' in all phases of the PhD programme, from the application to its conclusion, as well as guarantees support to the teachers and the teaching activities, managing also the International Cycle of PhD Conferences and other scientific meetings.

The supporting services of *Mundos Sociais* publisher and the journal *Sociologia, Problemas e Práticas* cover the entire editorial, publication and dissemination process of the books published by *Mundos Sociais*, the journal *Sociologia, Problemas e Práticas* and the *CIES e- Working Papers*. They also ensure compliance with the procedures for the inclusion of CIES-IUL's publications in scientific repositories and in national and international indexation databases.

Research team

The CIES-IUL research team includes researchers (integrated PhDs), associated researchers and research assistants. Integrated PhD researchers represent the core of the team, ensuring the essential coordination of research activities. Together, the CIES-IUL research team consists of almost three hundred members.

In 2018, one can highlight the stabilization of the constitution of the research team, with 121 integrated PhD researchers, corresponding to 73.4 FTE (Full-Time Equivalent).

It should be noted that in all categories the majority of researchers are female (55% of the integrated

PhD researchers, 68% of the associated researchers and 65% of the research assistants).

Integrated PhD researchers are mostly professors at ISCTE-IUL or full-time researchers at the Centre (postdoctoral fellows or hired researchers).


Another part of the integrated PhD researchers belongs to other national higher education institutions (15%), among which the University of Beira Interior (UBI) and polytechnic institutes of different areas (Health, Tourism, Education) and regions of the country (North, Central and Metropolitan Area of Lisbon). The seven integrated PhD researchers from the University of Beira Interior (UBI) integrate the CIES-UBI Pole.

The CIES researchers have a very positive record in obtaining research grants with 98 active scholarships (in 2018), of which 34 are postdoctoral and 42 PhD scholarships.

In 2018 CIES and ISCTE have made a strong effort to rapidly implement the FCT policy of scientific employment, transforming Pos-doc grants into research contracts. 25 applications for research contracts were opened and completed until December 2018. This fact, along with the new rectorate orientation to support scientific careers, will bring new possibilities

to structure and develop the fulltime researchers' careers, and improve scientific work.

It should also be noted the internationalization of the team with researchers from several nationalities. In 2018, 14% of the members of the research team are foreign, of 22 nationalities.

During 2018, the Centre welcomed 44 visiting researchers from Brazil, Cape Verde, Czech Republic, China, Germany, Greece, Italy, Spain, Switzerland, Turkey, United Kingdom and United States of America. Of these researchers, 29 were PhDs and 15 were PhD or master students who came to do research work for their thesis.

In 2018 CIES-IUL also hosted 61 guest researchers that participated in scientific meetings organized by members of the team, namely in the International Cycle of PhD Conferences.

In Memoriam Britta Baumgarten (1975-2018)



In October 2018, our dear colleague Britta Baumgarten passed away. Britta arrived at CIES-IUL in 2010 as a post-doctoral researcher, and she brought the best of her international training. She immediately established collaborations and spaces of dialogue with her colleagues, with a spirit of team and solidarity, far from any individualism. These were also the bases of her research work, reflected in her empirical and theoretical contribution to the area of social movements. Her studies have become central in this field, especially focusing on the crisis and austerity in Portugal and on the role of memory in contemporary mobilisations (as in the case of the memory of the Portuguese revolution). Her work on the role of culture, understood as both socialization and emotions, shaped her innovative analysis in the area of studies of social movements. These reflections were gathered in the book *Conceptualizing Culture in Social Movement Research* of which she was co-editor.

At CIES-IUL, Britta was always engaged in creating and maintaining open spaces for discussion, such as the Monthly Seminar on Social Movements and Political Action, to which she continued to dedicate effort and time also in the most difficult moments she was through in recent years. Simply, with passion, because she believed that the university should be, above all, that. She was always available to welcome and guide new researchers and students and to participate in dissemination activities.

All colleagues and the many friends Britta had at CIES-IUL are immensely grateful for the time they were able to spend with her, which will always be remembered for the intelligence, professionalism, loyalty and sensitivity she put into everything she did.

In honor of Britta and recognizing her work as a role model for social movement scholars, the *Social Movement Studies Journal* has created the *Social Movement Studies Britta Baumgarten Memorial Prize* to be awarded annually.

Research groups

The research activities are carried out within the framework of the Research Groups. CIES-IUL currently has six Research Groups: Inequalities, Migration and Territories; Knowledge Society, Competences and Communication, Family, Generations and Health, Politics and Citizenship, Work, Innovation and Social Structures of the Economy and Modern and Contemporary History.

The researchers' inclusion in the Research Groups is based on the themes associated with their research activities, which can be carried out in more than one group. There are also projects and other activities with cross-cutting themes that mobilize researchers from different groups.



Inequalities, Migration and Territories

Coordination: Luís Capucha and José Luís Casanova

Keywords: Inequalities and social classes; Poverty and social policies; Migrations and ethnicity; Territory, environment and sustainability.

The Research Group "Inequalities, Migrations and Territories" (RG IMT) consists of 33 integrated PhD researchers, 19 associated researchers and 20 researchers with doctoral scholarships and other research assistants.

Based on different theoretical perspectives and using diverse methodological approaches, the Group is a source of innovation, discovery and accumulation of national and international reference knowledge in its areas of research in areas such as: a) Social classes and social mobility; b) Social inequalities based on socio-occupational profiles, social classes, education levels, gender, ethnic background, age, income, poverty and social exclusion, lifestyles and consumption, among others; c) Immigration, ethnicity and Portuguese emigration at the level of both the

composition of international flows to/from Portugal and the social integration of migrants, refugees and their descendants; (d) Cultural values, identities and attitudes within the framework of shared European values; e) Cities and urban life, non-urban territories and environmental studies.

The research carried out has significant social impact that must be highlighted, namely in advising and evaluating public policies that promote inequality reduction.

The RG includes two permanent structures, the Inequality Observatory and Emigration Observatory (producing information for the whole national scientific system with wide public diffusion) and coordinates CIES-IUL's participation in the European Social Survey.

The RG integrates several research networks and international scientific structures and has likewise broadened its participation in international projects.

Knowledge Society, Competences and Communication

Coordination: António Firmino da Costa and Patrícia Ávila

Keywords: Education and Literacies; Science, Technology and Higher Education; Media, Internet and Social Networks: Arts and Culture

The core of the Research Group "Knowledge Society, Competences and Communication" (RG KSCC) is composed of 23 integrated PhD researchers from different generations, whose scientific work has as analytical focus the relations between knowledge and society, namely in a set of relevant institutional domains: education, science, communication and culture. The scientific activity of the RG also includes 29 associated researchers and 46 researchers with PhD scholarships and other research assistants.

In recent years the RG developed very positively in terms of scientific results, internationalisation, and social impacts. The team has been investigating a diverse but interrelated range of areas: schooling processes, inequalities and educational trajectories, education systems, reading and literacy, new literacies, lifelong learning, higher education networks, science and society, public engagement with science and technology, internet and social networks, journalism and media systems, culture and arts, and cultural facilities, agents and audiences.

In addition, a significant proportion of the RG's projects also make important contributions to the design, analysis and assessment of public policies in the education, science, communication and cultural fields, leading to guite relevant impacts. Besides scientific results in terms of advancing knowledge and social impacts, the RG has pursued two other primary goals. On the one hand, it has been strongly committed to both the integration and training of young researchers and the advanced training of PhD students, and the employment in science of young post-doctoral researchers. It is important to secure significant resources for this for 2018-2022, namely from FCT. On the other, the RG has systematically been oriented towards participation in international. and above all European and Ibero-American, scientific projects and networks. It is currently seeking an even more intense international presence.

In 2018, the Portuguese Observatory on Cultural Activities (OPAC) was constituted within the framework of CIES-IUL, which is responsible for its scientific coordination and functioning. Its mission is the study, production and public availability of rigorous and updated information in various cultural domains in order to contribute to the current debates in Portuguese society and to the formulation, monitoring and evaluation of public policies.

Research Group

Coordination: Maria das Dores Guerreiro and Graça Carapinheiro

Keywords: Family and Generations; Health and

Medicine; Gender; Lifecourse

The Research Group "Family, Generations and Health" (RG FGH) is composed of 23 integrated PhD researchers, whose scientific activity focuses on research on families, generations and health. Also participating in this RG are 7 associated researchers and 9 researchers with PhD scholarships and other research assistants.

In the last years the RG made positive advances in its scientific results and the social impact of its research. It also consolidated the establishment of international partnerships, jointly drawing up applications, pursuing research projects and increasingly publishing co-authored works.

Taken as a whole, the RG's research team has worked in domains like: a) families, parenthood and childbirth movements, family policies, gender, domestic violence, intimate lives and new gender identities; b) youth, children and youth wellbeing; ageing processes, life transitions, generational pathways and life course; c) health and illness in current societies; health policy and health governance; medical professions; biomedicine and alternative medicines; patient pathways in health systems; d) health, risk

and lifestyles; medical drug use; substance consumption and addiction.

A number of these projects make important contributions to the design and evaluation of public policies at the national, European and transnational levels. Besides its commitment to advancing knowledge in its own scientific domains, the RG has also sought to receive and train young researchers of different nationalities, both by giving advanced training to PhD students, and by incorporating young post-doc researchers into the team.

In 2018, the Laboratory for the Social Studies on Childbirth (nascer.pt) was constituted as a permanent research platform and hosted by CIES-IUL. Its aim is to foster knowledge about the conditions and characteristics of childbirth in Portugal, to contribute to the consolidation of the Sociology of childbirth and, at the same time, to develop synergies between structures and multidisciplinary approaches in the study of childbirth, both at national and international level. Through the production and dissemination of scientific information, nascer.pt comes to improve the discussion around policies, practices and paradigms of the childbirth.

Politics and Citizenship

Coordination: Helena Carreiras

Keywords: Political Representation; Political Behavior; Citizenship and Social Movements; Public Policies

The Research Group "Politics and Citizenship" (RG PC) is composed of 28 integrated PhD researchers. 10 associated researchers and 11 researchers with PhD scholarships and other research assistants. The group is diverse and balanced in terms of age, gender and disciplinary background. Its main objective is to understand, from an interdisciplinary perspective, the interactions between civil society, political institutions and political elites, with a view to improving the quality of these interactions and, thus, the quality of democracy. The group has four main research foci: a first one is related to political representation. Research projects in this area have been contributing to increase, from a comparative perspective, the knowledge of institutional forms of participation and political representation, especially in the crisis and post-crisis contexts. A second axis focuses on non-conventional forms of participation

and contentious politics. Related projects have focused on the role of social movements in reshaping socio-political landscapes, challenging consolidated party systems, creating new political actors, and in revitalizing civil society. A third area is connected to the analysis of public policies and the dynamics of public administration, and addresses the role of political institutions and public administration in the production and implementation of public policies. A fourth recently emerging area regards citizenship and social work. It centres on the professional practice of social work and looks at the development and conditions for implementation of social policies.

Work, Innovation and Social Structures of the Economy

Coordination: Luísa Veloso

Keywords: Social dynamics of the economy; Work, employment and professions; Innovation; Labour and industrial relations

The Research Group "Work, Innovation and Social Structures of the Economy" (RG WISSE) is composed of 6 integrated PhD researchers, 7 associated researchers and 2 researchers with PhD scholarships and other research assistants.

In the last years the RG has achieved multiple goals, representing both continuity and transformation. In terms of continuity, the RG focused on: professions and their associations and unions (financial analysts, artists, scientists, teachers, lawyers, expatriate workers - e.g. project "Business lawyers and large corporations: practices, identities and cultures"); industrial relations (e.g. "Portuguese Observatory of Good Labour Practices"); dynamics of the labour market, professions and their relationship with public policies (e.g. "Teachers in public education and teachers' unions in Portugal"). Examples of research on social change include: studies on science, technology and innovation (e.g. "Scientific Development

and Entrepreneurial Innovation"), and highly qualified employment (e.g. "Innovation networks and scientific employment"); the social construction of the financial markets; work representations in cinema (e.g. "Work on screen"); the servitization of the economy: posting workers abroad (e.g. "EU-Post Lab"); quality of life at work; gender equity at work; the economic crisis and transformations at companies (e.g. "Organizational strategies for adjusting to the economic crisis in Portugal, Spain and Greece."). The RG is also present in multiple (inter)national networks (e.g. Research Committee 07 "Futures Research", International Sociological Association; Research Committee on Sociology of Law, European Social Network: COST Action ISCH IS1001 - Bio-Objects and their Boundaries). Regular seminars promote closeness and dialogue between the RG's members. The creation of the CIES-UBI pole at Beira Interior University has enriched the RG with new scientific foci, namely the relationship between work and gender equality.

Modern and Contemporary History

Coordination: Magda Pinheiro and Luís Miguel Carolino

Keywords: History of science and technology; History of the environment and sustainability; History of the city, tourism and cultural heritage; Social dynamics, politics and citizenship

The Research Group "Modern and Contemporary History" (RG MCH) is composed of 10 integrated PhD researchers, 6 associated researchers and 5 researchers with PhD scholarships and other research assistants.

The researchers of this group came from ISCTE's Centre for Studies in Contemporary History (CEHC), which was incorporated into CIES-IUL as a RG in 2015. The Group conducts research in History from the early modern to the modern and contemporary periods. It is heterogeneous in terms of age, gender and topics of study, and this produces synergies between the different areas. As a whole, the researchers prefer a transnational approach to the different topics of research, a perspective that make it easier to work with international research networks in pro-

jects such as "Land, Power and Territorialities in Portuguese America". This kind of approach also enable some of its researchers to take part in international associations like the Commission Internationale pour l'Histoire des Villes, the Associação Ibérica de História Ferroviária, the Association d'Histoire des Sociétés Rurales, and the International Commission for the History of Universities. This is also reflected in participation in international publications in indexed journals or books and attendance at and arrangement of colloquia designed to bring Portuguese issues into international narratives. The Group also seeks to train new researchers, supervising around 30 PhD candidates whose research topics also add to the diversity of RG6's areas of study. The Group coordinates, and gives lectures for, the PhD in Modern and Contemporary History, and also participates in other PhD courses, such as PIU-DHist (Universities of Lisboa, Évora and Católica), which reflect its openness to new researchers and topics. In orienting its research work, RG6 constantly seeks conceptual and methodological innovation, an international framework and social meaning.

Overall research indicators

Research projects

Research is the central element of activities at CIES-IUL and is undertaken as part of projects performed by research groups.

The fundamental research projects at the centre are funded by public calls with scientific assessment issued by public and private, Portuguese and European agencies and foundations and applied research projects and knowledge transfer activities with consolidated scientific skills.


One of CIES-IUL's essential distinguishing features is that researchers can propose research projects and other scientific activities independently. This culture of initiative and cooperation is a firmly established practice. To a great extent, it is the source of the centre's ability to respond to the opportunities and challenges in research and enables us to place emerging, socially and scientifically relevant issues on the research agenda.

This practice is obviously encouraged among the younger generations working in the research group at CIES-IUL or in cooperation with researchers from other groups. Researchers often participate in the activities of more than one group.

There was an upturn in the number of funded projects in 2018 compared to 2017, going from 52 to 92. This improvement was due to national and international funding. Finance came from the FCT, other Portuguese public bodies such as ministries and local authorities, private organizations, the social sector and funding from the European Comission and other European institutions.

This success was due to a combination of public recognition of the quality of our research, the competitive bids submitted by the team in answer to external requests and the impact of CIES-IUL's dissemination and transfer of knowledge to society.

Publications

Publication is a core element of the centre's scientific activity, as it is a way of disseminating the results of its work to the scientific community and society as a whole.

Recent years have shown a transition in the publication pattern of the team of researchers at CIES-IUL. It has been increasingly aligned with international trends towards publication of articles in indexed journals as opposed to books or book chapters.

In spite of this progressive increase in articles in indexed journals in Scopus and the Web of Science (WoS), CIES-IUL researchers managed to keep a balance between the different types of publications, thereby ensuring the presentation of results to the international scientific community and dialogue with Portuguese society.

The number of publications reached 430 in 2018. The rate of publication in indexed journals was maintained (129) with a progressive quality enhancement as a result of the increase in the number of articles published in journals indexed in the the WoS (51) and Scopus (80) databases. There also continued to be a large number of publications of books, including chapters and authorship and coordination of books.

Under Other Publications, 123 are peer-reviewed (publication in proceedings of scientific events, working papers; project reports, reviews in journals) and the remaing include forewords, afterwords, non-peer-reviewed articles, and other publications.

The ratio of publications per full-time equivalent researcher are maintained, where those in indexed journals are 1.8 publications by FTE researchers of integrated PhDs.



Observatories and Laboratories

CIES-IUL fosters a number of permanent research observatories and laboratories in scientific relevant areas promoting public debate on pertinent issues in each area. The Inequality Observatory (OD) and the Emigration Observatory (OEm) have about a decade of existence and have achieved growing scientific and social recognition. Recently other two research platforms were created within the framework of CIES-IUL: The Portuguese Observatory on Cultural Activities (OPAC) and The Laboratory for the Social Studies on Childbirth (nascer.pt).

CIES-IUL is also an honorary member of the Communication Observatory (Obercom), which analyses

and assists in public policies, sector companies and academic research in communication sciences. The Family and Family Policy Observatory (OFAP) furthers and disseminates knowledge about families and family policies in Portuguese society under a partnership between ICS-UL, its scientific coordinator, and CIES-IUL.

CIES-IUL also integrates the Collaborative Laboratory for Work, Employment and Social Protection - CoLABOR, that was constituted in 2018 under the FCT attribution of the title of Collaborative Laboratory.


Inequality Observatory

CIES-IUL is responsible for the operation and scientific coordination of the Inequality Observatory (OD). Its partner institutions are Institute of Sociology (Instituto de Sociologia) at the Arts Faculty, Porto University (ISFLUP) and Centre for Social Studies (Centro de Estudos Sociais) at the University of the Azores (CES-UA). The OD studies different aspects of inequality. It conducts international comparisons of statistical indicators and a wide range of constantly updated studies and research.

In its implementation phase in 2008, it received the support of the Presidency of the Council of Ministers, the Ministry of Labour and Social Solidarity and the Ministry of Education. Since then it has been supported exclusively by CIES-IUL. In addition to fostering scientific knowledge in this area, the OD's mission is to publish accurate, up-to-date information on inequality from the viewpoint of citizenship and a contribution to the justification and assessment of public policies. This means that it is a tool for research and scientific dissemination. It is a founding member of the European Inequality Watch network, which involves similar observatories and other institutions from different countries.

Its website is designed to be a diversified information platform on social inequality issues and provides access to such records as a system of indicators, studies and projects, statistical databases, a bibliographic base, reviews of publications, news, interviews and links to other websites. https://observatorio-das-desigualdades.com/

Every year the OD organises a colloguy with specialists and representatives of civil society organizations. In 2018, this colloquy was commemorative of the Observatory's 10th anniversary. The event included the Conference "Inequality and Democracy" with Colin Crouch (Max-Planck-Institute), the presentation of the study "The Labour Market in Portugal and Europe: Statistical Overview 2018", a round table "Portugal in the next 10 years: what (dis)equality?" and the launch of the book "Social Inequalities - Portugal and Europe". The book presents a multidimensional perspective in the analysis of the processes and results that produce inequality. To this end, twenty-two chapters are organized in four major themes to cover a multiplicity of differentiated studies and address the problem of social inequalities considering a comparative analysis that frames the reality of Portuguese society in the context of the European space.



The texts are the result of research developed at CIES-IUL by authors from different social sciences and with diversified institutional paths. In addition to

the great scientific diversity, this publication brings together several generations of researchers who not only share concerns and reflections on contemporary society, but also share theoretical and methodological heritage that resulted from a fruitful accumulation of scientific knowledge that has occurred in CIES-IUL over the last three decades. In this sense, it is a long-lasting publication made of the crossroads between many paths and multiple professional and life experiences.

With regard to events in 2018, the Observatory of Inequalities also participated in the XII Meeting of Sociology of the Azores at the University of the Azores, dedicated to the theme "Social Inequalities - perspectives and changes that count", organized by the Interdisciplinary Centre of Social Sciences - CICS.NOVA.UAc with the communication entitled "Portraits of young workers: towards a sociological understanding of precariousness".

The OD Diretor will co-organise the Research Stream RS11 - Questioning Precariousness: Labour, Collective Organising and Everyday Life in the European Sociological Association congress in 2019.

Throughout the year a vast number of indicators were produced and disseminated (e.g. public expenditure on social protection, health, education and R&D; level of education; early abandonment of education and training; life expectancy at birth; infant mortality; risk of poverty; Gini coefficient; S80/S20 ratio - income inequality).

Emigration Observatory

The Emigration Observatory (OEm) is an independent technical and research structure integrated in the Centre for Research and Studies in Sociology (CIES-IUL) of ISCTE-IUL. The Observatory functions on a partnership basis between CIES-IUL and the following university institutions of research: the Centre for Research and Studies in Sociology (CIES-IUL) of the University Institute of Lisbon (IS-CTE-IUL), which ensures the coordination of the partnership; the Centre for Geographical Studies (CEG) of the Institute of Geography and Spatial Planning of the University of Lisbon (IGOT-UL); the Centre for Research in Economic and Organizational Sociology (SOCIUS/CSG), of the Institute of Economics and Management of the University of Lisbon (ISEG-UL); the Institute of Sociology (IS-UP), of the Faculty of Arts of University of Porto.. Its interdisciplinary research team has the support of a Scientific Committee made up of specialists from Portuguese universities. The OEm communicates with its target population every day through its website (http://www.observatorioemigracao.pt).



As in previous years, in 2018 the Emigration Observatory continued to publish indicators on emigration and updated its periodic compilation of statistics on Portuguese emigrants arriving and living in host countries. The OEm team continued to work every week with the media, publishing useful research to civil society and political audiences, as well as commenting on news about Portuguese emigrants.


The OEm releases publications on Portuguese in terms that are accessible to non-specialists. In 2018, it published three new numbers of the collection, "OEm Conversations With" featuring interviews with migration experts; a new OEm Country Report on France was prepared and will be released in May 2019; two new OEm Fact Sheets on Portuguese emigration to Canada, 1966-2016 and Portuguese skilled migration in DIOC [Database on Immigrants in OECD Countries] 2010/11; a new OEm Working Paper on discourses on identity among Portuguese emigrants living in London, and the Portuguese Emigration Factbook 2017 in English.



The OEm continued to work with government emigration institutions, including work on the publication of Emigração Portuguesa. Relatório Estatístico 2018 [Portuguese emigration. Statistical Report 2018] partially included in the annual report on Portuguese emigration by the Office of the Secretary of State for

the Portuguese Communities and discussed in the Parliament concerning the public policies targeting emigrants.

In 2018 the team has also worked on the first issue of the new collection of books The Current Portuguese Emigration to be published biennially from 2019. The books will include a commented synthesis of the main statistical indicators and a set of contributions based on the results of completed or ongoing research.



Also in 2019 the book New and Old Routes of Portuguese Emigration: Uncertain Futures at Periphery of Europe, organized by Cláudia Pereira and Joana Azevedo (eds.) will be published by the international publishing house Springer, under the collection of IMISCOE, the largest European network of scholars in the area of migration. This publication is the result of the contribution of authors who participated in the international conference on "Contemporary Portuguese Emigration", organised by the Migra Network and the Emigration Observatory, with funding from FCT and the Office of the Secretary of State of the Portuguese Communities.

Portuguese Observatory on Cultural Activities

The Portuguese Observatory on Cultural Activities (OPAC) was launched in 2018 within the framework of CIES-IUL, which is responsible for its scientific coordination and functioning. Its main goals are to ensure the development of accurate and up to date research and public availability of studies and information related with various cultural domains and themes aiming to contribute to current debates in Portuguese society and the formulation, monitoring and evaluation of public policies. Despite the strong emphasis on Portuguese reality, OPAC also has a transnational comparative perspective, particularly within the EU.

Laboratory for the Social Studies on Childbirth

nascer.pt

The Laboratory for the Social Studies on Childbirth (nascer.pt) is a permanent research unit, recentely lanched and hosted by CIES-IUL. Its aim is to foster knowledge about the conditions and characteristics of childbirth in Portugal, to contribute to the consolidation of the Sociology of childbirth and, at the same time, to develop synergies between structures and multidisciplinary approaches in the study of childbirth, both at national and international level.

CoLABOR

CoLABOR is the Collaborative Laboratory for Work, Employment and Social Protection that was constituted in 2018 under the FCT attribution of the title of Collaborative Laboratory.

With nine partners CoLABOR is based on an innovative partnership that involves academia, private companies, entities from the social and solidarity sector, as well as the public administration.

In addition to multidisciplinary academic research units (economics, law and sociology) it engages companies that are particularly sensitive to the transformations of work and their impacts on social protection models. From banking to industry, from distribution to agri-food sectors, CoLABOR involves companies which employ a significant work-force nationally, are present throughout the territory and have an international projection. In light of the specificities of the Portuguese social security and social care provision models, in which the State and the social and solidarity sector are fundamental anchors for thedevelopment of solidarity dynamics, CoLABOR also engages both the public administration and representative entities of the social and solidarity economy sector.



4.1 PhD programmes with connection to CIES-IUL

Advanced training is a fundamental pillar of CIES-IUL. The Centre has extensive experience in hosting PhD students, based on a strong link between teaching and research. The PhD students are guided by experienced researchers, who provide the necessary support and supervision to carry out quality research.

Within the framework of the School of Sociology and Public Policy of the University Institute of Lisbon (IS-CTE-IUL), CIES-IUL has, since 2011, ensured the scientific coordination and executive management of four PhD programmes:

- Sociology
- Public Policy
- Communication
- Social Work

Also within the framework of the School of Sociology and Public Policy of ISCTE-IUL, CIES-IUL is the reference research unit for two other PhD programmes:

- Political Science
- Modern and Contemporary History

The Centre is also part of following PhD joint programmes:

- Communication Studies: Technology,
 Culture and Society (FCT PhD)
- Inter-University PhD Programme in History: change and continuity in a global world - PIUDHIST (FCT PhD)
- Political Economy (promoted in association by ISCTE-IUL, University of Coimbra and the University of Lisbon)
- Urban Studies (promoted in association by ISCTE-IUL and the New University of Lisbon)

PhD programmes coordinated by CIES-IUL

Since 2011, CIES-IUL has been coordinating the PhD Programmes in Sociology, Public Policy, Communication Sciences and Social Work. A doctoral program in Administration and Management Policies was presented to the National Accreditation Agency of Higher Education.

The programmes have a duration of three years. In the first year, the students attend seminars on theories and methods, as well as optional curricular units. In the other two years, they prepare their PhD thesis, carrying out research at CIES-IUL. Complementarily, they attend a Doctoral Seminar, the International Cycle of Doctoral Conferences and the Doctoral Colloquium.

PhD students regularly participate in the activities promoted by CIES-IUL and are encouraged to publish the results of their research in stages and to participate in national and international debate activities. The Centre's support structures ensure the necessary follow-up, both in the administrative management of the students training path and in their research activities. In this context, CIES-IUL supports

PhD students or candidates in the preparation of applications for scholarships from the national Foundation for Science and Technology (FCT), the ISCTE-IUL and other funding institutions.


PhD students also have access to specialised software (SPSS, MAXQDA, Qualtrics, etc.), to ISCTE-IUL laboratories (namely, the Laboratory of Communication Sciences and the Computer Laboratory), and to the ISCTE-IUL Library and access to the Online Knowledge Library (b-on), which provides access to the full text to thousands of journals and ebooks of the main international scientific publishers. Doctoral students with exclusive dedication and scholarships are offered a working space in a shared office.

The four PhD programmes coordinated by CIES-IUL have registered a high demand every year, which often exceeds the number of vacancies available.

In the last six years, 122 doctoral theses have been defended by students of the four PhD programmes managed by CIES-IUL.

Twenty-two doctoral theses were defended in 2018.

Doctoral colloquy

The doctoral colloquy of the ISCTE-IUL School of Sociology and Public Policies (ESPP) is an annual event. Third-year students present and discuss current research in the different PhD courses at the ESPP. In the 2018/19 academic year, the Fourth ESPP Doctoral Colloquy took place from 8 to 11 April

and was attended by over 50 doctoral students, researchers and lecturers. The idea was to inform the community of ongoing research in these programmes and foster broad public debate on problems, methods and results.







Other advanced training activities

Summer schools

In 2018, the 7th edition of the Illicit Drugs in Europe: Supply, Demand and Public Policies international summer school (www.drugsummerschool.cies.iscteiul.pt) was held with the co-organization of CIES-IUL and IPPS-IUL/ISCTE-IUL, with the collaboration of

the European Monitoring Centre for Drugs and Drug Addiction (EMCDDA) and NIDA (International Programme), in which 52 students from 22 countries participated.



Research internships

Another activity that links research and advanced training is the CIES-IUL Research Internships, which host undergraduate, master and PhD students in ongoing research projects.

In 2018, 9 trainees were welcomed under this initiative and, since its creation at the end of 2012, a total of 67 internships of this nature have been carried out.

Trainees are supervised by the research project coordinator of which they are part, may use empirical data produced by these projects for the purpose of carrying out research, master's theses or PhD theses and may rely on the project coordinator or other researchers in the team to supervise their thesis.



Scientific events

CIES-IUL organises initiatives that contribute to an environment of permanent, up-to-date scientific debate. In addition to scientific events as part of research projects or on the initiative of research team members, CIES-IUL also organises regular activities. The following are examples.

CIES-IUL Research Forum (annual)

The Centre has organised the CIES-IUL Research Forum every year since 2006. The subject of the 2018 forum was "Populism: an interdisciplinary overview".







CIES Research Workshops (fortnightly)

These research workshops are regular meetings for the presentation and discussion of processes, methods and results of social science research. CIES-IUL held 12 workshops in 2018.



International Cycle of PhD Conferences (annual)

The ESPP International Cycle of PhD Conferences takes place throughout the year and includes lectures organised as part of the school's doctoral programmes in Political Science, Communication, African Studies, History, Defence and Security Studies, Public Policies, Social Work and Sociology.

The speakers are internationally renowned specialists and many of the lectures are the result of the partnership between the different programmes.



Monthly seminar on social movements and political actional

These seminars began in 2014 and foster multidisciplinary reflection on social movements and different forms of political action, militancy and activism. They are designed to start an in-depth, ground-breaking debate on different perspectives, methodologies and approaches. They take advantage of Portugal's geographic, linguistic and epistemological position to cross-reference different European, North American and South American traditions of studies on social movements and political action and cover cases and areas that are often excluded from these studies, such as Portuguese-speaking African countries. There were nine seminars as part of this initiative in 2018.



Meetings about Migration Experiences



The MIGRA network and Emigration Observatory (OEm) organise these meetings. Their main goal is interdisciplinary exchanges on studies of international migration. Each meeting focuses on specific ongoing or completed work and research and cross-references practices and questions on methodologies and theories. Four meetings of this nature were held in 2018.

Biography and Trajectory Seminars Cycle (quarterly)



This cycle of seminars propagates the work of Portuguese and foreign researchers who use a biographical approach or use life course methods. It stimulates reflection on the collection, construction and interpretation of reports and biographical timelines and may set up research networks in the study of biographies, life paths and social trajectories. Two seminars were held in 2018.

Montlhy Meetings on Cultural Experiences



These meetings are jointly organised by CIES-IUL, DINÂMIA/CET-IUL and CHAIA (Évora University). They give a say to professionals and their experiences in the world of contemporary arts. They are designed to provide knowledge and discussions on a wide range of micro to macro projects and institutions in policy, management, creation, mediation and cultural and artistic intervention. Each meeting presents a case, which is commented on by a guest speaker and discussed by the audience. Five meetings took place in 2018.

Group Interpretation Workshop

This workshop was set up to discuss, nurture and disseminate advanced methodological skills in the CIES-IUL team. Group interpretation as a form of triangulation is used in qualitative social research to achieve a deeper, more complex understanding of the subject and also a crucial discursive way of ensuring inter-subjective transparency during the research process. Three workshops were held in 2018.

New Perspectives on Modern History

Through the presentation of some ongoing projects, developed by Portuguese and foreign historians from various universities, specialties and generations, this cycle of seminars allows to know the current trends of research in Modern History: the topics currently more developed, the main problems in focus, the new methodologies, the sources used, the new interpretations that are being produced.

The New Perspectives in Modern History cycle has been running regularly at ISCTE-IUL since 2005, aimed especially at master's and doctoral students from the History Department, but open to all interested parties.

Leituras ETNO.URB



The Leituras ETNO.URB [ETNO.URB Readings] are a series of discussion sessions around works and texts in Urban Ethnography, starting from an individual reading. The sessions are presented by members of the ETNO.URB network that includes researchers in social sciences organized around Urban Ethnography, based in Portugal and with a strong presence in Brazil. The sessions take place in the various institutions were the the members belong and they were 3 in 2018.

Other important discussion activities

Every year the CIES-IUL team members organise many events. In addition to these regular initiatives, some of the events with the highest international impact in 2018 that took place at CIES-IUL/ISCTE-IL were the following:

17th Biennal Congress of the European Society for Health and Medical Sociology (ESHMS): Old tensions, emerging paradoxes in health: rights, knowledge, and trust



This congress is one of the main events worldwide in the field of medical sociology and sociology of health and illness and took place in Portugal for the first time with over 300 participants from all over Europe and beyond.

TICYUrb - Third International Conference of Young Urban Researchers

An international event that aimed to echo frontier research, artistic works and professional practice related to different urban contexts around the world, in an interdisciplinary discussion between researchers from different academic and professional backgrounds and linked to multiple activities. In parallel with the conference sessions, there were open de-

bates among young professional, exclusive networking sessions, and field excursions, among other activities.



It follows the FICYUrb — First International Conference of Young Urban Researchers (2007) and the SICYurb - Proceedings of the Second International Conference of Young Urban Researchers (2011) that took place also at ISCTE-IUL resulting from the initiative of researchers from CIES-IUL.

TICYURB was a collaborative effort with the Research Center on Socioeconomic Change and Territory (DINAMIA'CET-IUL), the Interdisciplinar Center of Social Sciences (CICS.NOVA), the Institute of Sociology – University of Porto (ISUP) and the School of Architecture of the University of Sheffield (SSoA).





From Birth to Health: Towards Sustainable Childbirth



This conference was held under the COST Action BIRTH (Building Intrapartum Research Through Health) that involved 100 scientists, artists, professionals, activists, political stakeholders and service users from around 30 countries in Europe and beyond who got together to unveil the complexity within normal childbirth physiology in different populations, individuals, and contexts, with a positive, salutogenic approach.





Promotion of Scientific Culture

The development of initiatives promoting scientific culture has been one of the Centre's concerns since it was founded and researchers have participated actively and regularly.

CIES-IUL is a subscriber of science proximity initiatives organised by Agência Ciência Viva. They are Science and Technology Week and school-holiday scientific activities for young people. CIES-IUL has

also participated regularly in the European Researchers' Night, which is funded by the European Commission.

The centre's research team members also undertake other activities promoting scientific culture, including events for the general public, scientific articles, participation in TV programmes, book releases, etc.

Science and Technology Week and Science in the Holidays for Young People

Science and Technology Week and the Science in the Holidays for Young People programme enable young people to come into contact with everyday life, people, projects and methods at a research centre as part of the research conducted by CIES-IUL researchers. In 2018, for the 19th year in a row, CIES-IUL organised an event in Science and Technology Week, promoted by *Agência Ciência Viva*, in which 60 upper secondary school students spent time with researchers and projects at the centre.





Science and Technology Week

CIES-IUL also set up the 14th internship as part of school-holiday scientific activities for young people in collaboration with *Agência Ciência Viva* in 2018. Secondary students were hosted for two weeks. During the internship they had initial contact with scientific research and the work of sociologists. In the first

week they learned research techniques and methods and in the second they conducted research into a subject of their choice (monitored by CIES-IUL researchers). The results were presented at ISCTE-IUL.



Science in the Holidays for Young People "To be a Sociologist for 15 days"

European Researchers' Night

European Researchers' Night is funded by the European Commission (Marie Curie Actions). Its activities took place throughout the year and culminated in a night of celebration of science, which brought researchers and public closer together in a number of European cities on the last Friday in September.

CIES-IUL is a member of the SCILIFE - Science in Everyday Life Consortium and was responsible in 2018 for two activities that were held at the Portuguese Science and Natural History Museum at Universidade de Lisboa.

Firstly, with a music improvisation within the scope of "Orquestra Geração" (Generation Orchestra) which aims to provide sucessful educational and social insertion paths through music with a performance by the *Combo GeraJazz*.



The other activity was a guided tour through the neighbourhood of Quinta do Mocho showing the urban art on display in that neighbourhood which has become the largest open air art gallery in Europe. This activity included an opportunity for participants to create their own mural.



These activities were conceived within the project "Cidades em Mudança: processos participativos em Portugal e no Brasil" (Changing Cities: participative projects in Portugal and Brazil) with the researchers Graça Cordeiro, Otávio Raposo and Ricardo Bento from CIES-IUL as well as Renata de Sá Gonçalves and Alessandra Barreto (UFF, Brazil) and Julia O'Donnell (UFRJ, Brazil).



Publishing Activities

CIES-IUL has published the scientific journal *Sociologia*, *Problemas e Práticas* (SPP) since 1986. The centre has had its own publishing house, *Mundos Sociais* since 2010. It publishes the SPP journal and peer-reviewed social science book collections. The centre also belongs to consortiums that manage the indexed journals *Portuguese Journal of Social Science* (PJSS) and *Observatório* (OBS*) and publishes the *CIES e-Working Papers*.

CIES-IUL actively follows an **open science** policy. SPP articles and the CIES e-Working Papers are available to everyone in the RCAAP (Open-access Scientific Repositories in Portugal).

CIES-IUL was a pioneer at ISCTE-IUL in providing open access to its publications at the ISCTE-IUL repository. It has been its largest contributor of scientific documents (about 2500 deposited). The centre is a founding member of the Portuguese Social Information Archive (APIS) and Production and Archive of Social Science Data (PASSDA) which stores and shares data produced in social science research projects.

7.1 Sociologia, Problemas e Práticas

Sociologia, Problemas e Práticas is a scientific journal whose main purpose is to publish sociological articles resulting from original research, the development of theory, or thematic review. It also accepts interdisciplinary papers from other social sciences.

Sociologia, Problemas e Práticas addresses an international audience, publishing articles in Portuguese, English, Spanish and French, by authors from various countries. The journal is governed by principles of scientific quality, paradigmatic pluralism and social relevance. It aims to ensure that the articles published in the journal make a significant contribution to the advance of knowledge.

Articles submitted for publication undergo a blind independent peer review by at least two scholars recognised in their fields of expertise. Sociologia, Problemas e Práticas is indexed in various international bibliographic databases, namely Scopus-SCImago and SciELO Citation Index. Presently it is located in the Quartile 3 of Scopus-SCImago Scientific Journal Rank (SJR), in the fields of Sociology and Political Science and Social Sciences (miscellaneous).


The journal *Sociologia*, *Problemas* e *Práticas* was established in 1986 and has been published without interruption. In 2018 its three annual numbers were published regularly and punctually. Number <u>89</u>, the first of 2019, came out in late 2018.

The journal is published in print and online (open access) via SARC/RCAAP and SciELO.











Portuguese Journal of Social Science and OBS*

CIES-IUL is part of the consortium that publishes the journal Portuguese Journal of Social Science and the e-journal OBS*.

Portuguese Journal of Social Science is published by Intellect and is managed by a consortium formed by ISCTE-IUL, CIES-IUL, CIS-IUL and Dinâmia'CET-IUL. It is indexed in the following databases: SCOPUS, Capes-WebQualis, Cambridge Scientific Abstracts, ISBSS, Sociological Abstracts, Worldwide Political Science Abstracts, Latindex, EB-SCOhost. In 2018, three issues of the journal were published.

The journal OBS* is published within the scope of the collaboration of CIES-IUL and OberCom (Communication Observatory), being an interdisciplinary journal, open to contributions from disciplines related to communication studies, which publishes articles in English, Spanish, Italian, Galego, French and Portuguese, in open access. The journal is indexed in several databases, such as Scopus Elsevier/Scimago, ERIH-PLUS and SciELO.

In 2018, the OBS* journal maintained the course of its activity ensuring the regular and timely publication of its 4 annual volumes,.

7.4 CIES e-Working Papers

The main goal of the <u>CIES e-Working Papers</u> (e-WP), series, initiated in 2005, is the publication of scientific papers in electronic format that result from research developed by CIES-IUL researchers, as well as by researchers who collaborate with members or activities of the Centre.


A total of 9 CIES e-Working Papers were published in 2018, and a total of 212 working papers have already been published. They are available, in Open-Acess, in the ISCTE-IUL Library Repository, where they can be searched by date, author, title or theme.



CIES-IUL Website and CIÊNCIA-IUL

In 2018 a new <u>CIES-IUL website</u> was launched in connection with the CIÊNCIA-IUL portal for a more efficient collection and updating of information on the team and its activities.

The <u>CIÊNCIA-IUL portal</u>, which combines the scientific production of all the ISCTE-IUL community members, is the main source of information on the <u>CIES-IUL research team</u> and its activities. It is from this portal that the indicators of scientific activity of the Centre are managed..



CIES-IUL in the media

CIES-IUL keeps up its active communication via its website, the media and social media. Some researchers have a regular presence on television programmes or in regular columns in the written press. Some CIES-IUL events also receive wide media coverage. They include the Public Policy Forum, which was associated with TSF radio station and included live broadcasts on the *Quadratura do Circulo* debate programme on SIC television.

Funding and expenditure structure

Sources of funding

CIES-IUL sources of funding are very diversify reflecting the researchers' proactivity in the search for funding opportunities and the intense dialogue with multiple institutions and actors. This was particular evident during the economic and financial crisis, but has always been a mark of Centre. As a result, the main sources of funding of CIES-IUL are not only FCT programmes, but also other public bodies, private institutions, local authorities and also the European Union Programmes.

In the last three years (2016-2018) the funding of research activities and support facilities fluctuated as a result of the unpredictability of the issue of calls for applications for projects and funding cycles resulting from FCT institutional assessment processes.

An analysis of CIES-IUL income in 2018 shows a slightly growth in the Centre's overall budget. The results of applications for FCT projects were announced leading to a substantial increase in the funding from FCT research projects. Another im-

portant change in this year was beginning of the replacement of post-doc grants with research contracts following Ministry of Science scientific employment policies. There was also an increase in income from research projects funded by other public bodies and funding resulting from participation in European projects

In terms of funding, information about the value of FCT post-doc and doctoral grants for CIES-IUL is also relevant. Although the FCT doctoral grants are paid directly to the researchers, this process has a direct impact on the funding of the Centre's research. In the last three years the overall Centre's level of funding from indivual scholarships has been very similar (around 1 million Euros) but there has been an important change concerning the two types of scholarships: the PhD scholarships shows a clear pattern of growth and the Post-doc scholarships decreased in 2018 (mainly as a result of the conversion to research contracts).

Expenditure structure

With regard to overall expenditure, there has been a gradual transformation of the expenditure structure. Human resources are still the highest item but with a lower overall percentage. This item includes the salaries of employees at CIES-IUL's central services (science management and communication, financial project management and researcher support, PhD management and the publishing department), grant-holders at the observatories, research fellows, provision of services in research projects and researchers hired under the "Investigador FCT" programme.

The support provided to researchers by CIES-IUL for participation in scientific congresses, colloquies, etc and for the translation and revision of articles for publication in indexed international journals has grown regularly, that in 2018 was about 55% of the global expenditure.

The Centre's expenditure is generally balanced, in spite of uncertainties regarding institutional funding, and sufficiently flexible to accommodate unexpected expenses without this affecting sustainability.
