# THE MULTIFACETED VIEW OF POLITICAL REPRESENTATION BETWEEN LIBERAL AND ANTI-LIBERALS REGIMES IN EUROPE AND SOUTH AMERICA

The crisis of representative democracy is one of the most debated and controversial issues in contemporary politics. Victor Orban, the Hungarian Prime Minister, stated in 2018 that the era of liberal democracy is over. That statement underlines one main point: the crisis does not necessarily concern the democratic regime but, mainly its liberal dimension.

The aim of this workshop is to explore the roots of the multifaceted idea of representation, that is, to discuss representation not only considering the liberal-democratic model but also (and mainly) those in the anti-liberal field. In particular the workshop aims to assess representation in three different versions: first, the liberal-democratic one, focusing on the complicated and even contradictory relationship between the principles of popular sovereignty and the rule of law: second, the organic representation established between the end of the 19th century and the first half of the 20th and at the roots of the fascist regimes; third, the populist idea of representation with its associated idea of democratic regeneration through the recovery of popular sovereignty and, to recall Carl Schmitt, the prevalence of legitimation over the rule of law.

Finally, the panel discussion will take in consideration not only European cases but Latin American ones as well in order to develop a broader understanding of the multifaceted idea of representation through a comparative analysis.
